## 2019 VENDOR PROGRAM



Purchases on qualified models made through these authorized distributors will first be reported to LG for review and approval and will operate on a quarterly cycle with program payout approx. 30-45 days at close of the previous quarter. Those quarterly cycles are identified as follows.

Quarterly Reporting Periods			
Q1	Apr – Jun 19'	Submissions due by July 31st	
Q2	Jul – Sept 19'	Submissions due by October 31st	
Q3	Oct – Dec 19'	Submissions due by January 31st	
Q4	Jan – Mar 20'	Submissions due by April 30th	

### III. Additional Terms

- HTSA associate members who buy through one of the authorized LG distributors are eligible to receive group sales driver benefits (Direct non-eligible)
- Payment is calculated on net quantities after returns are applied
- Direct Dealers are not eligible for sales driver program
- Out of territory shipping voids eligibility of sales driver program
- LG and NMG reserve the right to change and determine eligibility of the sales driver program
- Sales Driver amounts are subject to change based on model carryover and/or price moves
